Job Summary:

Under general supervision, maintain and repair grounds irrigation systems. Modify existing systems and assist in the planning, cost estimating and installation of new systems.

Essential Functions:

50% Perform all essential functions of an Irrigation Specialist. Assist in installation and maintenance of sprinkler/irrigation systems. Establish and maintain sprinkler system preventive maintenance programs. Plan irrigation systems, select types of irrigation equipment, estimate costs and install or modify sprinkler systems.

45% Perform all tasks of a Groundskeeper (mows, weeds, trims turf, snow removal etc.).

0-10% Complete work, time and material usage reports. Perform other duties as assigned by Superintendent/Supervisor.

Education:

Requires high school diploma or GED and successful completion of The University Job Enrichment Training Program for Grounds.

Licenses/Certifications:

Valid Ohio Driver's License. Valid Ohio Pesticide License.

Experience:

Requires a minimum of 2 years experience in Groundskeeping working with irrigation/sprinkler systems and one year as an Irrigation Specialist with The University of Akron. Ability to operate equipment and machinery such as string trimmers, snow blowers, augers, push mowers, cushman scooters, tractors, salt spreaders, back hoes, chain saws, tow motors, riding mowers and trenchers required.

Leadership:

Provide guidance to nonexempt staff including general scheduling, assigning tasks and monitoring the work of others, as assigned by the Supervisor.

Physical Requirements:

Must be able to lift 80 pounds without assistance and demonstrate bending, crouching and lifting. Must be able to climb a ladder, scaffolding and work from rooftops.

Working Conditions:

Routine exposure to heat, cold, moisture/wetness, inclement weather, noise, air pollution and heights. May involve exposure to chemical substances, hazards and moving parts. Work schedule is subject to change in accordance with University needs and/or the results of the shift line-up process. Overtime/Call-ins may be mandatory based on University need.

The intent of this classification specification is to provide a representative summary of the types of duties and responsibilities that will be required of positions given this title and shall not be construed as a declaration of the specific duties and responsibilities of any particular position. Employees may be requested to perform job-related tasks other than those specifically presented in this description. The University requires that all University employees whose assigned duties include some involvement with The University of Akron's intercollegiate athletics program, comply with all relevant NCAA Bylaws in performing their work.
