Job Summary:

Provide medical care and health counseling in a college ambulatory care center in accordance with professional nurse practitioner standards and in collaboration with physicians. Assess diagnoses and treat acute health problems. Provide health counseling and education through health awareness programs and/or activities.

Essential Functions:

60% Obtain medical histories and perform physical examinations in order to diagnose and treat primary care level health problems, as well as counsel patients regarding healthy lifestyle practices. Perform orders and interpret laboratory tests as needed for diagnosis and treatment in accordance with CLIA guidelines.

30% Provide primary level gynecologic care, education and guidance about contraceptive choices.

10% Participate in planning and implementation of departmental programs to educate students and develop staff.

Education:

Requires a relevant Master's Degree.

Licenses/Certifications/Requirements:

All Required: RN license in the State of Ohio, Adult or Family Health Nurse Practitioner Certification, Nurse Practitioner Certificate of Authority (COA), Certificate to Prescribe (CTP) as issued by Ohio Board of Nursing, Basic Life Support (BLS) Certificate

Experience:

Requires a minimum of 1 year experience employed as a nurse practitioner in a college health, ambulatory care, urgent care or private physician's practice. Ability to document and maintain health related records in accordance to University procedures required. Ability to promote the health maintenance and wellness of students and staff through health counseling, screening and the development of health awareness programs and/or activities. Strong interpersonal skills in working with and educating a diverse university community required.

Leadership:

Responsible for directing and monitoring the work of student and/or temporary workers.

Physical Requirements:

Light physical effort required involving stooping and bending; individual has limited discretion about walking, standing, etc.; occasionally lifting of lightweight objects (up to 25 lbs.).

Working Conditions:

Routine discomforts from exposure to moderate levels of heat, cold, moisture/wetness, noise and air pollution. May involve routine/occasional exposure to light chemical substances or hazards (radiation, chemicals, diseases, heights and moving parts).

The intent of this classification specification is to provide a representative summary of the types of duties and responsibilities that will be required of positions given this title and shall not be construed as a declaration of the specific duties and responsibilities of any particular position. Employees may be requested to perform job-related tasks other than those specifically presented in this description. The University requires that all University employees whose assigned duties include some involvement with The University of Akron's intercollegiate athletics program, comply with all relevant NCAA Bylaws in performing their work.
